1. FINANCE

- a. Council received and filed the report of the CAO/Treasurer regarding the 2021 Second Quarter Financial Report.

2. OPERATIONS

- a. Council received the report of the Director of Operations regarding preliminary design for reconstruction of Valentina & Third, Derby, Kentail, Mutual and Holland Street projects; and that Mandi Pearson, Clerk/Operations Clerk be authorized to sign the Municipal Engineering Agreement (MEA).
- b. Council adopted the report of the Director of Operations regarding the Phase 15 of the Woodland Park (Giampietri) development for Assumption; and that By-Law 44 and 45 of 2021 be enacted.

3. COMMUNITY SERVICES & FACILITIES

- a.
