8. DELEGATIONS / FIRST OPPORTUNITY FOR PUBLIC TO ADDRESS COUNCIL

- 1. Presentation from Mandi Pearson and Thera Wagner on behalf of the Mommy Market Group of funds raised through the Spring 2014 Mommy Market Sale in support of the OHDCC Backyard Project, the cheque presented was for funds raised of \$2400.00
 - Mayor McCharles thanked the ladies for their efforts with Mommy Market, not only are they staff but also volunteers in our community and that is great to see.
- 2. Mr. Andy Hart, 562 First Ave Tile Yard Municipal Drain
 - Mr. Hart thanked Council for hearing him this evening as he addressed recent concerns regarding the Court of Revision and Assessment for the Tile Yard Municipal Drain that he and his neighbours affected by the assessment have;

Enniskillen Township is a largely farm based community, with low population density, where proper drainage is a necessity (using the municipal 'flow over 24 hours' basis). Paying for drain maintenance is a business cost offset by various grants. Individual costs are proportional to the benefit they realize. The Tile Yard Road Drain (and the following road resurfacing) is an improvement of the current situation.

Petrolia Town is a largely residential / small business community with much higher population density, where again, proper drainage is a necessity (using the larger storm drain sizing model). In town, the improvement / maintenance cost has been town not individual based.

The Town and Township are common in that the crown of the road is the highpoint with surface drainage into the set back at the sides. Within the setbacks, drainage and maintenance is the responsibility of the Township and Town. Individual properties adjoin the setbacks. The difference is that within town, individual properties are on both sides of the street, whereas the Tile Yard boundary puts Township properties on one side and Town properties on the other.

The Tile Yard drainage proposal was first discussed with the engineer 'on site' in April 2013. Affected town residents weren't aware of the proposal until the report was issued in April 2014. The appeal process was explained in the 22nd April 2014 public meeting and the report received first and second readings at that time with subsequent minor adjustments of assessments in the court of revision meeting on 3rd June. We should have been involved from April 2013.

Discovery Line is a largely agricultural, business and oilfield location with low population density where the few property owners did contribute to the cost of their drainage improvements.

There was a big storm in I believe, 1996 with 4" of rain that flooded properties and basements in and around the Ignatiefna / Oozlovsky area of town. A large drainage upgrade was done at no cost to individual affected residents.

Recently, **Princess Street** underwent drainage and road improvements. Residents were not required to pay for this individually even though there is benefit in terms of curb appeal as well as drainage. All Town residents including ourselves have contributed to the cost through our taxes.

As part of the Town's established residential community we are asking to be treated similarly, where the Town assumes the cost of this improvement. *Thank you.*

- Mayor McCharles: What is the total non-agricultural portion for these residents?
 - Joe Adams: \$19 372.00, minus the recent deduction from Mr, Jonathan Hart's request to Enniskillen and the Engineer for reconsideration, granted for the amount of \$404.00. The total assessment for these residents will be \$18 968.00.
- Councillor Brown: I attended the meeting as the Town of Petrolia representative on the Court of Revision, and the meeting I asked how many instances has a joint drain project occurred. Mr. McTavish walked me through all the projects and there are a fair many of them, all of which the residents paid their portion of the project assessment.
- Mr. Gary McCallum, 563 First Ave Tile Yard Municipal Drain

- Mr. McCallum asked what did the residents on Discovery Line at that time pay?
 - Councillor Field: I asked staff to provide me with that information prior to this evenings meeting, and received a copy of the assessment from that project and it was approx.. \$10,000.00 for the residents portion
- Mr. Bill McNally, 559 First Ave Tile Yard Municipal Drain
 - Mr. McNally asked why when developed was storm water not considered at time of development?
 - Mayor McCharles agreed that at the time of development of the subdivision Storm Water Management should have been considered and included in the Plan of Subdivision
 - Joe Adams: recent changes through the Ministry now request that storm water be approved by the Ministry prior to any approval of a Subdivision Plan.
- Mr. Jonathan Hart, 564 First Ave Tile Yard Municipal Drain
 - Mr.Hart commented that as residents our tax rate is higher then what is paid by Enniskillen residents, therefore my taxes should cover this cost. When I was building, I was told to drain onto Tile Yard Road and at the time I questioned that but was told that was what needed to be done.
 - Mayor McCharles: there are no storm sewers in this area and the natural drainage flows into this drain.
 - Mayor McCharles:
 - Noted that Council does understand that concerns the residents have brought forward, the mistake was past history and made when the plan of subdivision was approved many years ago
 - Possibly staff could again review the assessments and come back to Council with a recommendation and a policy regarding Municipal Drain when the Town is affected
 - Joe Adams noted that all actions with this project and assessment have been followed through the Drainage Act and this procedure is common in many communities.

- 3. Alex Palimaka of Bluewater Power addressed Council with comments regarding the Green Energy Act plan before them this evening;
 - In the past Councils have been asked to endorse Municipal Energy Plans and Conservation plan, those plans were very different then the proposed plan tonight, the plan before Council tonight only speaks to Town owned facilities;
 - The 2% Energy reduction outlined can be achieved, the project models outlined are not requesting approval tonight, they are part of the plan for

consideration during capital budgeting. If all projects were approved over the next 5 years the Town would see an 14.5% goal achieved;

- This plan is meant as a financial tool for staff and Council to use as support and reference for the next five year period.
- 4. Mrs. Susan McQuaid 268 Parkside concerns regarding a letter that was recently forwarded to Mayor McCharles and Mr. Baron from her neighbor at 270 Parkside. This letter was addressed to the residents of Parkside Court and delivered to them
 - Thanked Council for hearing her this evening, 10 years ago she and her family moved to Petrolia as it was the kind of community they originated from and wanted to return to;
 - We would like to clear up some of the details of the letter, as the details are false;
 - The neighbor at 270 Parkside has ATV's, large 30 foot RV motor home and a pontoon boat, he has accused me of being a poor neighbor
 - This is not the case, we do many good neighbor things from lawncare to snow removal assistance
 - He has poured a large cement pad for his RV
 - We have constructed a fence on our property line that makes getting the RV in very tight
 - We have great concern over the safety of the kids in our neighbourhood when he is operating the large RV, as he has already hit another parked vehicle and we are worried he may hit one of our kids

Mayor McCharles noted that staff have heard the concerns tonight and will look further into them and will be in contact with Mrs. McQuaid.

- 5. Mr. Matt Miller 269 Parkside concerns regarding RV motorhome at 270 Parkside
 - Mr. Miller re-iterated the feelings and concerns from Mrs. McQuaid, there are many children on our street and we have a concern for their safety.
 - After staff have looked further into it how will the rest of us know the outcome?
 - Mayor McCharles noted that staff will report back to Council in a report, where a resolution where and if possible would be noted.
 - Where can we access this information?
 - \circ Mr. Baron noted that this report would be of public record for the meeting where the report is discussed and could then be found in the minutes of that meeting.
- 6. Ms. Julie Whitely Petrolia Toastmasters
 - In January of 2014 the Petrolia Branch of Toastmasters began
 - Toastmasters clubs are present in 122 countries, enables there members to increase communication skills and increase leadership skills
 - Requesting Council's support to become a mentor, messenger and motivator for the Petrolia branch and take the Toastmasters message to the community
 - Cost is \$25.00 plus \$125.00
 - Invited Council to attend the meetings as a guest or to join the club, meetings are Wednesday mornings at 7 at the OHDCC

Councillor Brown: it is very encouraging to see this activity happening, there is a lack of this resource in the community and schools where it should be being taught.
