February 20, 2024–7:00 p.m. – Regular Meeting of Council

The Council of the Town of Petrolia held their regular meeting in person on Monday, February 20, 2024, at 7:00 p.m. in Council Chambers at Victoria Hall.

At this meeting, the Council of the Town of Petrolia:

- Received a report regarding the Petrolia Line and Oil Heritage Road Watermain Replacement and Extension – Engineering Services, and approved that BM Ross be approved to proceed with the Civil Engineering Services in relation to the Petrolia Line and Oil Heritage Road Watermain Replacement and Extension in the amount of \$143,880.00 + HST.
- Received a report regarding the 2024 sidewalk replacement work, and approved that BM Ross proceed with the Civil Engineering Services in relation to the Garfield and Maple Streets connectivity in the amount of \$26,950.00 + HST.
- Endorsed a report regarding the quote results for the replacement fitness equipment at the Petrolia YMCA and approved the equipment purchase from FDF Group in the amount of \$43,853.50 + HST.
