

# Council News in Brief

February 24, 2025 – 7:00 p.m. – Regular Meeting of Council

The Council of the Town of Petrolia held their regular meeting of Council on Monday, February 24, 2025, at 7:00 p.m. in Council Chambers at Victoria Hall.

At this meeting, the Council of the Town of Petrolia:

- Heard a delegation from Pastor Alex Craig, Petrolia Ministerial Association. Council approved to waive the rental fees as was presented in the delegation.
- Received a presentation from Mr. Sam Smith from Ontario Clean Water Agency (OCWA) and endorsed as presented the 2024 annual report (Brights Grove Water Treatment Plant); and received and filed the 2024 MOE inspection reports.
- Received a presentation from Mr. Joe Bloomfield from Jacobs and endorsed as presented the 2024 wastewater treatment plant annual report.
- Received and filed a report regarding business licences and signage permits issued.
- Endorsed a report regarding the lottery update for 2024 and approved that the Town of Petrolia continue to waive the 3% licence fee eligible through provincial policy.
- Received and filed a report regarding the vital statistics update for 2024.
- Received and filed a report regarding the Active Transportation Fund grant application; and directed staff to submit the Active Transportation Fund grant application to the federal government by February 26, 2025, due date.
- Adopted a report regarding AGCO Significant Community Events; and approved the request to grant significant event status to the events for 2025 as listed in the report; and that the Clerk be directed to produce confirmation for use with the AGCO applications.
- Endorsed a report regarding the road closures and parade requests; and approved that the roads listed be approved for closure on the dates and times as listed; and that public notification be issued by the Clerk/Operations Clerk.
- Received and filed a report regarding the 2025 Compost Transfer Site and dates; and approved as amended to one date and change the July schedule, the 2025 compost pass fee, events and curbside brush collection dates.
- Mayor Loosley presented a notice of motion to come forward at the March 24, 2025, meeting to consider change of the council meeting date from Monday to Tuesday.
