Following a 5:00 p.m. Education Session with Mr. John Mascarin regarding Strong Mayor Power, the Council of the Town of Petrolia held their regular meeting of Council on Monday, May 26, 2025, at 7:00 p.m. in Council Chambers at Victoria Hall.

At this meeting, the Council of the Town of Petrolia:
