The Town of Petrolia offers electronic viewing of your Interim and Final property tax bills. By signing up for this service, you will be able to view your bill in a PDF format that will be sent to your email address in February and August.

If you sign up for this service, you will no longer receive a paper copy of the bill! If your bill is paid by your mortgage provider and you currently do not receive a copy of your bill, you may also register for this option.
