September 8, 2025 – 7:00 p.m. – Regular Meeting of Council

The Council of the Town of Petrolia held their regular meeting of Council on Monday, September 8, 2025, at 7:00 p.m. in Council Chambers at Victoria Hall.

At this meeting, the Council of the Town of Petrolia:

- Heard a presentation from Mr. Giovanni Spadafora, CPA, CA (Partner) regarding the 2024 audited financial statements as prepared by MNP, and approved the report as presented.
- Received and filed a report regarding approved site plan application and amendment applications approved under delegated authority during the month of August 2025.
- Adopted a report regarding the 2024 year-end financial results and Council approved, as amended, that the \$277K General Operating Surplus be transferred equally to the Working and Capital Reserve and to the budget stabilization reserve and approved the audited financial statements.
- Received and filed a report regarding the Budget 2025 Second Quarter (Q2) Financial Results.
- Endorsed a report regarding Sidewalk Sales and Events and approved that the six dates requested be given recurring permission to take place to allow for sidewalk sales downtown to allow for innovative promotions.
- Adopted a report regarding the ice allocation policy as amended and approved that this policy be used in the 2026-27 ice season following consultation with the user groups.
