
Council News in Brief

December 8, 2025 – 7:00 p.m. – Regular Meeting of Council

The Council of the Town of Petrolia held their regular meeting of Council on Monday, December 8, 2025, at 7:00 p.m. following a County of Lambton Public Information Session regarding the Southside S/E Quadrant Residential Subdivision and following the Public Information Session regarding the 2026 Budget and following the in-camera session in Council Chambers at Victoria Hall.

At this meeting, the Council of the Town of Petrolia:
